STEPS TO CERTIFICATION

GETTING STARTEDRead the Standard and Interpretation Guideline publications thoroughly to familiarise yourself with the Standard and its requirements.



LEARN

Attend training with the BRCGS Academy to gain a practical understanding of implementing the requirements.



REGISTRATION AND LICENCE AGREEMENT
Inform BRCGS of your intention to proceed with an audit. Complete and submit the relevant Licence Agreement and Schedule A document and pay any associated fees prior to your audit.



REVIEW

Perform a self-assessment gap analysis with the Standard (gap-analysis tool available on the BRCGS website). Assemble and train a team for implementation. Obtain consultancy if needed.



PREPARE
Use the outputs of the self-assessment to develop an action plan to implement the Standard requirements in your operation. Carry out risk assessments where needed and establish necessary control points. Prepare your procedures and undertake internal audits.



PLAN AUDIT

BRCGS certification audits are delivered by our network of approved certification bodies. A list is available in the BRCGS Directory. Contact your chosen or existing certification body to arrange an audit. Make sure you plan ahead so that staff are available and preparations are made.



ON-SITE AUDITThe audit will assess the practical implementation of the Standard requirements.
Observation of procedures and processes, review of documentation, and staff interviews will all take place.



NON-CONFORMITIES AND CORRECTIVE ACTION
If non-conformities are identified, you will need to carry out any corrective action, root cause analysis and plan preventive action. These will be closed out within 28 days following the audit.



CERTIFICATIONYour certification body will review the non-conformities and finalise the audit report to determine whether certification be awarded. If certification is achieved, the certification body will issue your certificate within 42 calendar days from the first day of your audit.









TRAINING FOR SITES PREPARING FOR FOOD SAFETY CERTIFICATION

- Be familiar with the audit protocol and understand the certification process.

TRUSTED TRADEMARKS AND WORLDWIDE ASSOCIATION ENDORSEMENT

The rigour of BRCGS Gluten-free certification has won the endorsement of a broad network of national and regional associations in the USA, Canada, and Mexico. This allows certificated sites to use the onpack association trademarks with the highest consumer recognition in their market, such as the Beyond Celiac trademark in the USA, the Celiac Canada trademark in Canada, the Acelmex gluten-free trademark in Mexico and Latin America, and the Association of European Coeliac Societies (AOECS) crossed grain symbol in Europe.

The strategic partnership between BRCGS and AOECS resulted in the collaborative development of Section 8 of the BRCGS Global Standard Gluten-Free. This optional section incorporates additional AOECS requirements into the certification process, specifically for sites looking to market their products in Europe and neighbouring economies. This streamlines the process for certificated sites and brands that feature the respected and trusted AOECS Crossed Grain symbol on their packaging.
